## Vinyl Fence Limited Lifetime Warranty

AmericanOne Fence & Railing, LLC warrants the original owner that Mainstreet Vinyl Fencing Products will be free from any manufacturing or material defects that result in peeling, flaking, blistering, corroding, rotting, or abnormal discoloration when subject to normal use and proper installation procedures. AmericanOne Fence & Railing, LLC limits this warranty to 30 years in the event that the vinyl fence is used for commercial use. The lifetime warranty intended to cover individual owners only, but only if the original purchaser remains as owner and primary occupant of the resident on which the product was originally installed. If the original owner were to no longer be a fulltime resident of the property, for any reason, the warranty coverage is automatically converted to a 30 year limited warranty with a starting date of the original installation.

The original owner is covered by this warranty as long as he owns and uses the property on which the product is installed as the primary residence. The lifetime warranty automatically ends upon the sale of the property or death of the last original owner of the property at the time of installation. Should any defects occur during the warranty period, AmericanOne Fence & Railing, LLC shall not be liable or responsible for labor charges or other expenses whatsoever in connection with removal or installation of either the original or replacement product.

### Limitations

This warranty covers defects in material and manufacturing. It does not cover failure or damage to the product caused by: Misuse or abuse, neglect, improper handling or storage of the product; Improper installation of the product; Impact of foreign objects; Fire, earthquakes, hurricanes, wind, tornado, or any other act of God; Settling or movement of the ground, soil or structure on which the product is installed; Normal weathering caused by the elements; Discoloration or chalking caused by mildew, air pollution (including but not limited to metal oxides or metallic particles) or harsh chemicals; Improper care or failure to provide reasonable and necessary repair of the product; Any other cause not involving manufacturing or material defects.

In no event shall AmericanOne Fence & Railing, LLC be liable to consequential or incidental damages of any kind, including any damage to the building, its contents or any person, resulting from the breach of this warranty.

### Registration of Warranty

To protect your rights under this warranty, the attached registration card must be completed, signed by the original purchaser, and returned to AmericanOne Fence & Railing, LLC within thirty (30) days of purchase. In the event the attached registration card is not returned within the thirty (30) day period, receipt of purchase must be provided by original purchaser to be eligible for coverage under warranty.

### Claims

All claims under this warranty must be submitted to AmericanOne Fence & Railing, LLC within thirty (30) days of the date the defect is first discovered. AmericanOne Fence & Railing, LLC must have a reasonable amount of time to inspect the product before the repairs begin. All claims must include proof and date of purchase, proof of property ownership, as well as a sample of the defective product.
